REPORT OF THE U.S.-CHINA CLIMATE CHANGE WORKING GROUP TO THE 8TH ROUND OF THE STRATEGIC AND ECONOMIC **DIALOGUE**

Koperna, Jr. attended the 3rd CCWG/CCUS Workshop in Xi'an, China in June 2016, under the CCWG's CCUS Initiative, the U.S. Department of Energy (DOE) and the National Development and Reform Commission of China (NDRC) are working together to facilitate the development of CCUS projects in both countries to ultimately help drive down the cost of commercial projects. He provided presentations on the Southeast Regional Carbon Sequestration Partnership's CO2 pipeline construction and infrastructure as well as the status of the International Organization for Standardization's Technical Committee 265 on carbon dioxide capture, transportation, and geological storage.
